Applicant: Woodstock Quarries Limited

Activity Description: Various activities associated with a new landfill proposal

As you are aware, I have been processing the above resource consent application. Before I can make any recommendations on the application, I advise that, in accordance with Section 92(2) of the Resource Management Act 1991 (RMA), I propose to commission a report concerning the application.

Requirement to Commission Report

I am satisfied that the proposed construction and demolition waste and contaminated soils landfill may have significant adverse environmental effects if the landfill is not located in a suitable geological setting and the proposed engineering design of the landfill is not in accordance with best practice guidelines or not suitable to avoid, remedy or mitigate any actual or potential adverse effects associated with the landfilling activity.

The proposed report will investigate the suitability of the geological setting and the adequacy of the proposed landfill engineering design. It will also confirm whether, from an engineering and geotechnical point of view, the environmental risk assessment has appropriately assessed the risks associated with the proposed landfill.

Further to that, I note that:

- Our inhouse scientists will also need to rely on the appropriateness of the landfill engineering
 and risk management assessment in order to provide their reviews of the actual and potential
 effect effects on the environment.
- The report will assist Environment Canterbury with the review (from a technical point of view) of the proposed landfill management plan and bond conditions.

• While not a major part of the report, the report will also provide a technical review of the air quality effects assessment provided in the application.

Please find attached a fee proposal from Tonkin & Taylor Limited, outlining the proposed scope of the review of the information provided in the application and associated costs.

In accordance with Environment Canterbury's charging policy the actual and reasonable costs of preparing this report will be charged to the application.

Please note that we require this information so that we can understand any potential effects from the application. If we are unable to do this, the application may have to be notified, or even declined.

Notification means that potentially affected parties and/or the general public are given the opportunity to raise their concerns or support for the proposal. This process does not guarantee the application will be granted, there is the possibility that it could be declined. Response Options

The options available to you are set out in Section 92B(1) of the RMA. You must choose one of the following:

- (a) Respond in writing (email is fine) by Wednesday, 12 May 2021 and advise whether or not you agree to the commissioning of the report.
- (b) Refuse in writing by Wednesday, 12 May 2021 to the commissioning of the report. Should you choose this option, Section 95C(3) of the RMA requires us to publicly notify the application.

If you chose not to respond to this letter, then the same process as for (b) applies.

I advise that in accordance with Section 88C(4) of the RMA, the processing of the application will be placed on hold from the date of this advice until the date that the technical report is received by Environment Canterbury, or, if you refuse to agree to the report being commissioned, the date of receipt of that advice.
