# 7. Reports

7.1 <u>Updated Waka Kotahi Investment Proposal and its impact on Regional Land Transport Plan priorities</u>

Steve Higgs provided an overview of the Waka Kotahi Investment Proposal and explained the changes to the earlier version that had been released in October

2020. Members were assured that earlier work had not be lost and the Road to Zero programme delivery had not changed; however, the programme being delivered had been repackaged and/or expanded to ensure it rolled out efficiently over the next 10 year period.

During discussion the Mayors advocated on projects vital to their communities. It was noted the revised list of projects presented to this meeting only identified the safety projects priced over \$2 million during the first six years, not the full ten year programme; therefore, low cost, low risk programmes were not itemised on the list.

#### Action:

1. <u>Steve Higgs</u> to provide a list of projects in the low cost low risk category to this Committee.

Concern was raised that the Ashburton community had not heard the outcome of the Selwyn to Ashburton submissions consultation. Waka Kotahi advised the scope of the project had changed, resulting in an unforeseen delay; however, community concern was noted and action would be taken to ensure the community would have an opportunity to be involved in the engagement phase. A timeline would be provided.

The Transport Officers Group, previous and current employees were complimented on their input to the draft RLTP, members sighting it as a good reference document on how Canterbury functioned.

Process of public and stakeholder engagement was deliberated.

Some minor corrections to the draft RLTP plan were noted, including:

- 'Hurunui Mouth Bridge' (page 52) to be clearly named as 'SH1 Hurunui Mouth Bridge' so as not to confuse with a bridge known by the similar name by locals
- Rakaia to Ashburton (page 51) to be updated to Selwyn to Ashbuton
- Cost of Christchurch City Council low cost low risk improvements (page 61) to include commas
- Consider adding a note not all projects are specified in the draft RLTP.

## 7.4 <u>Waka Kotahi Update</u> Refer page 76 of the agenda

Jim Harland and Steve Higgs presented on Waka Kotahi land transport updates and spoke of the non-state highway activities proposed for the National Land Transport Plan.

It was also noted:

- To achieve a 40% reduction in deaths and serious injuries on roads would require a major shift which would require large amounts of work on vehicle and road improvements.
- Part of the Vision Zero case studies may involve a subcommittee for approval of local speed limits.
- The Christchurch Northern Corridor was receiving positive feedback with improved journey times and was also popular with weekend cyclists. Special

asphalt that reduced vehicle noise would be laid once the road had been bedded in by vehicles.
