8. Cashmere Stream and Port Hills Working Group - Christchurch Adventure Park, Forestry and District Plan

Presentations were received as follows:

- District Plan – Planning Framework for Cashmere Stream Catchment – Mark Stevenson, CCC City Planning
- Christchurch Adventure Park – Charlie Lyons, Assistant Operations Manager
- Forestry on Banks Peninsula – Sarah Helleur, Environment Canterbury

Discussion followed the presentations and questions were responded to by Mark, Charlie and Sarah. A range of points were covered in the discussion about:

- The 8 person Trail Committee for the Christchurch Adventure Park is made up of experts in the field of erosion/sediment, forestry and plantings.

Councillor McInnes arrived at 7.35pm.

- Maintaining the control of sediment is dealt with by the forestry companies and then by the landowners once the land is back into their control.
- The method and regularity of cleaning out sediment traps was queried.
- Tunnel gully erosion creating under runners for water runoff is problematic.
- The time that plans are made is the best place to consider growth areas, separation of forestry from urban development areas.
- Outline development plans can include definitions of locations of springs and setbacks.
- The Cashmere Stream is identified as a Site of Ecological Significance in the District Plan. It is identified as a SES east of Cashmere Road (near Hendersons Road).
