8.3 Climate Emergency Update

Refer pages 45 - 46 of the agenda

Presented by: Cr Elizabeth McKenzie; Director of Science

Key Points

- Climate change proposed a direct threat to natural ecosystems through increased hazards, eg flooding, drought and fire. There was also an indirect risk through climate change induced land use change, making ecosystems vulnerable to invasive plant pest species and browsing mammals.
- In response to emerging risks, the Biosecurity Regional Pest Management Programme was moving away from a reactive approach, to prioritising resources and interventions at the start of an invasion curve prior to pest species becoming established.
- Environment Canterbury partners with Manaaki Whenua Landcare Research and AgResearch to develop models to predict potential for distribution of invasive species. Modelling includes different climatic scenarios for different pest species.

Models map a potential 30 invasive plant species. Of those, eight plant species were categorised as probable high-risk and were being investigated.

The eight species identified as highest risk of spread (from a list of 30):

1.	Rum cherry	Prunus serotina
2.	Himalayan balsam	Impatiens glandulifera
3.	Tree of Heaven	Ailanthus altissima
4.	Bermuda buttercup	Oxalis pes-caprae
5.	African love grass	Eragrostis curvula
6.	Nutgrass	Cyperus rotundus
7.	Noogoora bur	Xanthium strumarium
8.	Bathurst bur	Xanthium spinosum

Staff noted that this risk assessment should not be taken out of context. Three of the species above were not known to occur in Canterbury (CRPMP Exclusion pests). While the risk of spread might be high, the impact might be low. Other species may have slightly less risk of spread but their impact could be major.

The next step being taken this financial year is to understand the impacts, potential high-risk areas of occurrence and risk pathways for most of the 30 species.
