Purpose: Jet Boat racing on the Waimakariri River
Reservation: No vessel shall navigate within the Reserved Area as listed above except with the express permission of, and in a manner explicitly approved by, the certificate holder, his delegate or the Harbourmaster.
Conditions:
Publication of notice of Reservation: At least 7 days prior to event being undertaken, notification to known affected groups; notifications on appropriate websites and social media; notices at known boat ramps and key access points.

A copy of the Temporary Reservation Certificate to be carried by: Byron Campbell or delegated person.
Safety conditions: <ol style="list-style-type: none"><li>1. Every vessel operating under this Temporary Reservation shall do so in compliance with the Bylaw; and all relevant Maritime Rules except as exempted by this reservation; all relevant rules and codes of practice of NZJBRA. Updated operational safety plan to be complied with.</li><li>2. Every Vessel operating under this Temporary Reservation shall be made aware at a preliminary race briefing of the current 2021 NZ Jet Boat Waimak River Race SOPs in relation to river racing and follow then accordingly.</li><li>3. <i>All competitors are to be advised that whilst the rivers notified in this Temporary Reservation Certificate have been uplifted and reserved for the sole purpose of the races specified , should an unauthorised vessel be on the course, all vessels are immediately to comply with Maritime Transport Act 1994 Rules 91 and 22.
