Recommended change to proposed Plan Change 7 to the Canterbury Land and Water Regional Plan pursuant to Clause 16(2) of Schedule 1 to the Resource Management Act 1991 (RMA)

Proposed Plan Change 7 (PC7) to the Canterbury Land and Water Regional Plan (CLWRP) was publicly notified on 20 July 2019. The Council delegated to an Independent Hearing Panel ('the Panel') its powers to hear submissions on PC7 and make recommendations on those submissions. The Report and Recommendations of the Panel were presented to the Council at their meeting on 17 November 2021 and Council resolved to accept the Panel's recommendations and adopt them as the 'Council's Decision' on PC7.

Clause 16(2) of Schedule 1 to the RMA states:

"A local authority may make an amendment, without using the process in this schedule, to its proposed policy statement or plan to alter any information, where such an alteration is of minor effect, or may correct any minor errors"

The following amendment is recommended to correct a minor error in proposed Plan Change 7 (PC7) to the Canterbury Land and Water Regional Plan (CLWRP):

This amendment is within the scope of submissions received on PC7, specifically it provides the decision requested by Todd Property Pegasus Town Limited in submission point PC7-427.1.

It is considered appropriate to use Clause 16(2) to Schedule 1 to the RMA to amend proposed Plan Change 7 to the Canterbury Land and Water Regional Plan to make these changes as it is a clear

recommendation made by the Panel which was erroneously not shown in Appendix B, Part 1 of their report.

The correction would have a minor effect on the implementation of the planning framework as the region-wide provisions in the CLWRP that reference Schedule 6 are

- a. Rule 5.146A which applies to rivers, so is not applicable to Pegasus Lake, and
- b. Policy 4.31 and Rule 5.71 which manage stock exclusion from waterbodies, however due to its location, form and function, Pegasus Lake is unlikely to be accessed by stock.

Recommendation

The above change as recommended by Environment Canterbury staff, is approved as a correction of a minor error under Clause 16(2), and a copy of these changes is displayed on the Environment Canterbury Website.
