# 3. REGISTER OF INTEREST

The Register of Interests was reviewed by the Committee. There were no updates to be included from the Members.

#### 4. GENERAL BUSINESS

#### **Confirmation of Minutes**

#### **Matters Arising**

It was noted that the Rivers Team would provide a report on the flood risk from the Kōwhai River and options for low-cost mitigation. The Rivers Rating Meeting will be held in Kaikōura on the 8 March 2022 and is an opportunity with representatives from Kaikōura Water Zone Committee to be present.

Clint McConchie joined the meeting at 2pm.

Councillor Grant Edge raised an issue about the power company pruning native shrubs along State Highway One South of Kaikoura. The Kaikoura Water Zone Committee agreed to follow up with the power company and respond back to the Committee with the findings. This was assigned to Jaimee Grant.

Several initiatives were presented to the Committee for their consideration to support using the Kaikoura Zone Committee Action Plan Budget Fund – refer attached presentation. Some initiatives were immediately deferred as further information was required before a resolution could be made.

# **DOC Library Trap Project**

Jemima Rodden from Department of Conservation (DOC) provided an update on the DOC Trap Library project, the following was highlighted:

- There has been positive feedback on this to date however it is not being widely publicised as there
  are only limited traps
- Support was shown for this project with the Committee wanting to increase the number of traps available to enable the public to be involved
- It was suggested by a committee member that a course be provided on correct use of the traps with extra funding needed.

It was discussed whether funding this project fell into role of the Water Zone Committee, the following was noted:

- DOC funding is for public land only and not community/private property with DOC leading Predator Free NZ 2050
- Councillor Edge would discuss with ECAN Biosecurity Team in Amberley to see if there is funding within another budget

- ECAN are looking into buying cat traps
- Nicky McArthur noted DOC should be managing the recording of trapping nationally.

A formal proposal would be tabled to the next meeting for the Committee's consideration and precirculated next week. Gina and Jemima to liaise re: including community trapping project. A request was made that the Rūnanga projects be sent to the Committee. Clint agreed to organise.

# Puhi Peaks/Shearwater/Stream Trapline – presented by Nicky McArthur

- There are two wild colonies remaining in the world which are subject to major threats, especially disease. In totally there are 3,000 breeding pairs remaining at the Puhi Peaks site
- Pests have decimated the other six colonies, the last remaining two were being protected from pigs however, rats might be able to get higher due to climate change and impact the colony
- Puhi Peaks staff, time and resources are at capacity of managing their 300 traps
- QEII funding sought which will partially contribute to the trapline project but not enough to complete project with current inputs
- The funding request for \$15k would pay to set the traps up, including cost of labour and materials which would need to be helicoptered in. Their request for funding was turned down by Jobs For Nature as they are not coastal based.

The Zone Committee confirmed for Jaimee that that the objective, "coordinating and supporting on the ground action such as trapping and planting" was not intended to be limited to wetlands as suggested by its location the action plan under the protection and enhancement of wetlands subheading.

# Waikōau Lower Lyell "Street and Beach Clean-up" - presented by Health Melville

- Sport Tasman are organising the event including coordinating students to volunteer for clean ups. In general, volunteers are still showing interest.
- Heath would provide communications to the committee when ECan hold planting days / immersion days.
- Jaimee agreed to work with the Zone Manager to get a Waikōau/Lyell Creek action plan outlining the upcoming events for the Committee.

Nicky McArthur left the room. A conflict of interest prevented her participation in the decision making.

# BACKGROUND

The Kaikōura Zone Delivery Team, which has now been operating since April 2015, was the first of six Zone Delivery Teams to be established in Canterbury to support the region's 10 zone committees.

# Kaikōura Water Zone Committee – 3 Year Action Plan 2021–2024

The purpose of the agenda item is for the Kaikōura Water Zone Committee to consider and decide whether to support an initiative using the Zone Committee's Action Plan Budget for the 2021-22 financial year.

# 2. RECOMMENDATION

That the Kaikōura Water Zone Committee:

- 1) **Receives information** on the DOC Trap Library initiative to be considered for support using the Kaikōura Zone Committee Action Plan Budget; and
- 2) Confirms the Kaikōura Water Zone Committee:
  - a) Supports the DOC Trap Library to be recommended for funding using the Kaikōura Zone Committee Action Plan Budget; or
  - b) Requests further information on the DOC Trap Library initiative before making a decision to support or not support a recommendation to fund using the Kaikōura Zone Committee Action Plan Budget; or
  - c) **Does not support** the DOC Trap Library initiative be recommended for funding using the Kaikōura Zone Committee Action Plan Budget.

# 3. BACKGROUND

As part of their Long-Term Plan 2021-2031, Environment Canterbury established the Zone Committee Action Plan Budget (formerly referred to as the Community Engagement Fund) and committed \$50,000 per zone for the 2021-22 financial year.

The confirmed purpose of the budget is to allow Zone Committees to focus on implementing their action plan and leverage other funding opportunities to achieve the CWMS priorities.

# 4. NOVEMBER WORKSHOP - INITIATIVE DISCUSSION

The Zone Committee considered several draft initiatives at their 28 November 2021 workshop and tentatively supported the following, subject to further details being provided:

- Waiau Toa Revegetation Initiative (\$6,000-\$10,000)
- Waiau Toa Monitoring and Data Collection (\$8,000)
- Hāpuku Catchment Collective (\$20,000)
- Mt Ross Wetland (IMS waitlisted project) (\$8,000)
- Waikōau/Lower Lyell "Street and Beach Clean up" (\$200)

The Puhi Peaks Trapline project was deferred to the next meeting due to time constraints.

# 5. JANUARY MEETING - CONSIDERATION OF INITIATIVES

At their 28 January 2022 meeting, the Zone Committee formerly considered the initiatives discussed at the workshop and two new initiatives were noted for their information. The scope of some initiatives changed as a result of further information received.

Following consideration, the Zone Committee made decisions to:

- 1) **Support** the following initiatives to be recommended for funding using the Kaikōura Zone Committee Action Plan Budget:
  - Hāpuku Catchment Collective (\$25,000)
  - Puhi Peak Shearwater Stream Trapline (\$15,000)
  - Waikōau/Lower Lyell "Street and Beach Clean-up" (\$200)
- 2) Request further information on the following initiatives before making a decision to support or not support a recommendation to fund using the Kaikōura Zone Committee Action Plan Budget:
  - Mt Ross Wetland (IMS waitlisted project) (\$8,000 EST)
  - Waiau Toa Revegetation Initiative (\$6,000-\$10,000)
  - Waiau Toa Monitoring and Data Collection (\$TBC)

Two new initiatives were noted to the Zone Committee for which further information was requested:

- Tirohanga project (IMS waitlisted project) (\$TBC)
- DOC Trap Library (\$TBC)

The Zone Committee may consider supporting the above projects for the 2022-23 Financial Year.

Based on the above recommendations, \$40,200 of the \$50,000 of the Zone Committee Action Plan Budget has now been allocated for the 2021-22 Financial Year.

# 6. DOC TRAP LIBRARY - INITIATIVE FOR THE COMMITTEE'S CONSIDERATION

The DOC Trap Library initiative will be presented by Jemima Rodden, Department of Conservation (DOC).

This initiative will establish a trap library for community use and will be managed by DOC. This resource will enable increased predator control within the community and support the Predator Free 2050 goal and biodiversity outcomes.

The initiative aligns to the following actions outlined in the Zone Committee Action Plan:

- Sharing information and resources with our community to enable good kaitiakitanga of our zone.
- Coordinating and supporting "on the ground" actions such as trapping and planting (through trapping funding).

Further details of the proposal will be provided to the Committee when available.

The purpose of the agenda item is to confirm what action will be taken in response to the Coastal tree pruning issue.

# 2. RECOMMENDATION

That the Kaikōura Water Zone Committee:

• **Confirms** the next steps to be taken to raise and address the Coastal Tree Pruning issue.

# 3. BACKGROUND

At the Zone Committee's January meeting, Councillor Edge noted several native trees had been hedged to keep the powerlines clear along State Highway One, south of Kaikōura. It was noted the management of these trees could be improved by appropriate pruning to support the health of the trees.

The Zone Committee agreed to follow up with the power company and respond back to the Committee with the findings. This was assigned to Jaimee Grant.

It has been determined that a formal resolution by the Zone Committee is required in order to put a request through to an organisation e.g. Environment Canterbury and/or Kaikōura District Council, to follow up with the power company. Consequently, this issue is being put back to the Zone Committee to determine the next steps including whether it is appropriate for the issue to be raised directly by the Zone Committee and if not, who the Zone Committee should direct a request to.

Following a discussion with Chair T Howard, it was determined this issue should be considered within the context of the Canterbury Water Management Strategy (CWMS) to help determine the next steps.

# 4. TREE OWNERSHIP AND MAINTENANCE

MainPower New Zealand Limited (MainPower) are responsible for maintaining the lines within the Kaikōura area. Their website notes that tree maintenance is the responsibility of the owner (<a href="https://mainpower.co.nz/network-safety/trees-and-power-lines">https://mainpower.co.nz/network-safety/trees-and-power-lines</a>). The land containing the trees is held by Te Rūnanga o Ngãi Tahu.

In certain circumstances, the distributer (MainPower) may undertake tree maintenance in place of the owner as outlined in the Electricity (Hazards from Trees) Regulations 2003. Confirmation is being sought to determine who is undertaking tree maintenance.

# 5. CWMS RELEVANCE TO THE ISSUE

# **CWMS Targets and Goals**

Further discussion is warranted on the issue within the context of the Canterbury Water Management Strategy.

CWMS areas of relevance could be:

- Ecosystem Health/Biodiversity, and/or
- Recreation and Amenity Opportunities.

# **Zone Implementation Plan (ZIP)**

There is a particular focus on the transport corridor with an emphasis on taking a collaborative and co-ordinated approach to managing key issues that impact water management including freedom camping, weeds and pests, and the impact of the transport corridor. The priorities outlined in the ZIP are more specific to water and activities that impact on the water e.g. fish passage, waste from freedom camping. Priority 5.4 recommends the improvement of environmental values of rivers, streams, hāpua and wetlands crossed by or adjacent to the railway, State Highway, and local road network as part of maintenance and development projects. It notes management of weeds along highway and railway corridors as a part of that recommendation.

The purpose of the agenda item is for the Zone Committee to receive an update on actions undertaken and next steps to address the Kōwhai River shingle issue.

# 2. RECOMMENDATION

That the Kaikoura Water Zone Committee:

- **Receive** the information provided on the Kōwhai River shingle issue including actions to date and next steps.

# 3. BACKGROUND

As part of their Long-Term Plan deliberations, the Kaikōura District Council (KDC) received a submission highlighting the issue and subsequent risk posed by the shingle material sitting up the Kōwhai River. The KDC have requested the ownership / liability be addressed with Environment Canterbury and the Zone Committee.

The 2016 M7.8 Kaikōura earthquake generated thousands of landslides, created over 200 significant dams and damaged hillslopes across the Kaikōura zone. Consequently, significant landslide debris deposits still sit upstream of several rivers in the Kaikōura zone including the Kōwhai River.

This debris, when mobilised, will create new hazards including, but not limited to, further landslides and increased river channel instability. These hazards may persist for decades and therefore represent a prolonged risk that must be managed by the impacted communities and stakeholders. Extreme weather events with very significant rainfalls could trigger landslide debris volumes to mobilise and flow downstream causing inundation of the surrounding land. The Kōwhai River, in particular, presents a risk given the debris volume sitting upstream which could lead to inundation in an extreme weather event. Given the impacts of climate change, the likelihood of extreme weather events is increased.

At their 26 November 2021 meeting, the Zone Committee discussed the risk and potential mitigation options regarding the Kōwhai River shingle issue. The main issues are a build-up of shingle and weed which create banks to deflect the water and it was recommended that these are removed.

It was agreed that information was required from the ECan Rivers Team, specifically a report on the risks (and potential strategies) is needed for the Kōwhai River. A resolution was passed to request a report from ECan Rivers on the risks and potential strategies on the Kōwhai River, in the light of the increase in risk, and any funding implication in the annual plan.

At the Zone Committee's 28 January 2022 meeting, it was noted the Kaikōura River Rating meeting would be held 8 March 2022. The issue will be raised at that meeting with Zone Committee representation in attendance.

# 4. UPDATE ON NEXT STEPS

Chair T Howard, Councillor Edge and J Grant met with the Regional Lead – Rivers Engineering. A general discussion noted that the Kaikōura Scheme review is underway and discussions with mana whenua regarding the direction of the scheme have begun. A report is being drafted which will be shared with the district and the Zone Committee when available for the purpose of consultation.

It was noted maintenance works are undertaken including rock protection works and spraying. Some spraying works are undertaken on parts of the Kōwhai River's fairway as part of the regular maintenance works. For upcoming works, refer to River Protection and Drainage Schemes page on the Environment Canterbury website (<a href="https://www.ecan.govt.nz/your-region/your-environment/river-and-drain-management/flood-protection/">https://www.ecan.govt.nz/your-region/your-environment/river-and-drain-management/flood-protection/</a>). T Howard noted this will not be enough to significantly reduce the risk.

The issue will be discussed further at the Kaikōura River Rating meeting with T Howard in attendance. The discussion and outcomes of that meeting will inform the report on the Kōwhai River as required by the resolution.
