Jesse Burgess presented an update on the integrating urban land use programme including Canterbury Regional Transport Committee and GCP work programmes.

Key Points:

- There were comments around the excitement of technology and its benefits for transport services.
- There were questions around the need to make bus services more attractive and accessible to all of greater Christchurch. Service uplifts, Upgrades and fares were discussed in detail.

 Partnership supported the provision of more housing, but this needs to be done
 in an appropriate way such that good quality, sustainable urban environments
 are achieved.
