Tell us more about why you support the selected bus fare option.

I come from an area with students and friends alike who all use the bus as much as I do to get into town or get to school, and even though I may be almost 17, I am not oblivious to the financial strain it puts on their families. For some of my friends, catching the bus isn't a privilege they can always count on for education, either because their parents cannot afford to spare the money, or because they need to put it towards other necessities. I feel as though especially for youth in New Zealand, educational opportunities shouldn't be limited to if a person can or cannot pay for the transport to get there. I also believe that bus fares are crucial to upbringing. Many of the older generation would complain and compare our youth to theirs, saying that we are growing in a privileged environment and aren't meeting the standards that they did, but you need to understand and put in place the current mental wellbeing of our youth. I have met children who are younger than me struggling with families, struggling with school, and struggling with themselves. Unable to leave home or go outside for their Haoura, and usually its money that gets in the way of this. I want to see the teens after me and the teens around me develop into healthy hardworking people, but it is hard to do this with all the other variables that are enforced on them.

Any other comments on bus fares?

Explaining to people what tickets to buy when going from a zone 1 to zone 2 travel could be useful to saving money, I've talked to a lot of my friends who I had found out for ages had been not using the zone system correctly and ended up buying 2-3 separate tickets instead of 1.
