Option 1 (preferred): Fare-free for under 25s, students, Total Mobility and Community Services card holders

Tell us more about why you support the selected bus fare option.

Look, the fares are high and a disincentive to anyone to take the bus. With the focus on climate change and emissions reduction, a dearth of free parking and costs of parking available, fuel costs, with a week's unlimited bus use within Zone 1 for 1 adult coming in at \$26.50, Zone 1+2 \$38.50 and Zone 1+2+3 \$47.00. That includes for any adult. Beneficiaries, those who can't, won't or don't want to drive, pay parking, and may have the time to use to wait on buses, and disabled patrons. The bus service, which is, for me, very very good in metropolitan Christchurch needs to make itself an attractive option. \$6.00 on the buses or \$8.00 on fuel and parking, well, the differential is not enticing. \$0.00 and \$8.00 fuel and parking becomes a real alternative. Beneficiaries, those that don't drive, the disabled and students both young and matured, already do it hard. A bit of relief, for either having to or choosing to, help with reduction in traffic congestion, air pollution, and general consumer demand for vehicles and fuel, should be acknowledged and rewarded.

If I had my way the fares would be free, or at least minimal, for all and sundry, all the time. I believe free public transport should be in the purview and focus of any responsible and caring council. It a hope. It is wish.
