I think it will do the most to encourage more people to use public transport, however I'm concerned that it doesn't do anything for those over 25. I also think there are cleverer tricks available- see my comment to question 11.

Any other comments on bus fares?

When you travel by car, if you add more people to the car the cost doesn't increase. However this is not true of bus travel – it costs twice as much for two people to travel by bus as one person. I think you should create a household fare structure, where you can register several metrocards to a household and those metrocards would have a common balance (making it easier to top up) and, most importantly, a common daily and weekly maximum. This should be set the same as or very close to the daily and weekly maximums for an individual, so that households are encouraged to have more people travel by bus. I would mean, for example, that if one adult commuted by bus Monday-Friday, the whole family could travel for free at weekends.
