Tell us more about why you support the selected bus fare option.					
I believe uptake of public transport in Christchurch is higher for younger age groups currently. Option two would do the most to support uptake in 26-65 year olds, while still supporting families by reducing child fares. Option two could be sold with a targeted marketing campaign aimed at those who work in central Christchurch. \$4 per day for transport is much cheaper than city parking - putting this price in front of more people and challenging their decision to pay more for parking could support uptake and reduce private vehicle trips to the central city. Option two also supports uptake from Rangiora and Rolleston by capping the fare for a trip at \$2. This is crucial to reduce congestion and pollution on busy routes in to and out of Christchurch, especially as these towns grow.
