Tell us more about why you support the selected bus fare option.

We support free access to public transport for youth. Our suburb has an excellent bus route to the central city and free fares will encourage our youth to use it and to not use cars. We are also a suburb that has high tourist numbers and experience pressure on parking during the summer months. Access to free youth bus fares will encourage families to use the bus network and to alleviate road traffic and parking for both sumner and our neighbouring suburbs

Any other comments on bus fares?

We do have some concerns regarding 16yrs and under being able to access bus routes freely. This is not a fare issue it is more related to minors being able to travel across the city without restrictions of payment which would involve parental input. Will there be any measure put in place to monitor 12 - 16 yr olds travelling alone?

Is borrowing and repaying through general rates the right approach for this regionally significant event?

Payments from general rates could be applied to those outside the district where main arterial routes are affected (bridges and roads)

Where the event impacts areas that are wider than the region (power, transport access) then it would be appropriate for the costs of the recovery to be applied to the wider community via rates.

Option 1 (preferred): Redistribute rates in the Ashburton River rating district.

Any other comments on flood protection in Ashburton?

the costs should be reviewed so that the Ashburton River rating district pays a larger proportion of the costs. The costs for the roading and access reinstatement can be shared across the districts.
