Tell us more about why you support the selected bus fare option.

Option 1 - I disagree with only because under 25's who are working have more expendable income and normally are not paying rates. Giving them free bus fares is totally removing their ability to contribute to reducing climate change, and they are already the ones who will most benefit from reducing any climate change measures so they absolutely should contribute, at least by paying the bus fare and subsidising other users with less financial freedom. They have to pay if they don't take the bus, they have options. I totally support free bus fares for children, Total Mobility and reduced fares for CSC and students.
