Tell us more about why you support the selected bus fare option.

My number one reason for supporting the free fare option is because of the urgency of climate change. We are in a climate emergency, with the impacts of climate change visible everywhere. We need to be doing everything possible to reduce our emissions, and public transport is a huge part of this. This is particularly the case for Canterbury, where a huge proportion of our GHGs come from transport. Free fares, with urgent and widespread implementation, is one equitable and courageous action on the scale our climate needs. What's more, the high cost of transport, including public transport, leaves many of us disconnected from family, friends and activities that bring us joy. With housing costs and other expenses rising, many people find public transport unaffordable, at the time when we need connection and community more than ever. The SuperGold card has proven that free fares really encourage people to get out and about, which improves wellbeing. Families in particular need free fares. Cost barriers to public transport remain for families. Free fares for under-25s will help normalise public transport habits in the next generation, and lower the barrier for families enjoying public services and spaces such a libraries, parks, and beaches. What's more, free fares will be a boost for local business. When the cost of transport is prohibitive, businesses get less customers, community groups lose participants, and volunteers and tourist spots miss out on visitors. Free fares will allow more people to make these trips, connecting communities so we are all better off. While the government is committing to take action to reduce emissions and improve equity, now is the time to take this step. We cannot wait for length trials when the recent IPCC report has clearly stated that there is no time to lose, and we need to be mobilising at wartime speeds to avoid devastating climate change impacts. People and the climate need free fares now.

I would love to see this experiment taken further in the future, with free fares offered for everyone, not just targeted groups!
