#### Tell us more about why you support the selected bus fare option.

I chose option one because it is closest to my real preference, which is free fares for everyone. Removing the cost barrier and the hassle of paying on entry will make public transport much more appealing. More people using public transport instead of private cars makes the city a better place, and also reduces our emissions, and that's worth spending my rate payer dollars on.

#### Any other comments on bus fares?

The ideal situation in my opinion is to have free fares for everyone. I think the revenue lost from the tiny proportion of people who would still be paying in the option one scenario is not worth having the complexity of having a payment system for only a few people, and having to check everyone's ID. Furthermore, the more people who can access free and hassle free public transport, the more people are likely to choose that over private cars. Fewer people travelling by car means less congestion, less demand for roading upgrades (a cost saving), lower emissions (a high priority), and an altogether more pleasant city. Due to my own personal circumstances, I am unlikely to take advantage of free fares myself, but I consider that I would still benefit from all the advantages noted above, and I consider that worthwhile expenditure of my rates.
