Tell us more about why you support the selected bus fare option.

Kia Ora, my name is Cora Scott and I am a year 13 student. and I have lived in Christchurch my whole life. I wholeheartedly support making fares free for under 25s, students, Total Mobility and Community Services cardholders. In Christchurch, 53% of our carbon dioxide emissions come from transport. An equitable, accessible public transport system is vital if we are to meet our goal of becoming carbon neutral by 2050. A major barrier to accessibility and equity is the cost of public transport fares. For many people in Christchurch, it is still cheaper to travel in a private car, despite the ownership costs, the harmful emissions, and the increased congestion this causes. As someone who regularly travels using buses, the sinking feeling of realizing you've run out of money on your metro card and will have to find an alternative means of transport, is all too familiar. By making public transport free for these groups ECAN is removing this barrier and helping to make it easier for more people to choose a more sustainable transport option. It also signals ECAN's commitment to lowering Christchurch's emissions. The climate crisis is happening now and now is the time to support people to choose sustainable transport. However, environmental concerns are not the only reason that free buses are important-it is also a matter of making Christchurch a more equitable city. In her book, Invisible women, Caroline Criado Perez explains that not only are women more likely to use public transport but they are also more likely to make multiple transfers as they are often responsible for additional chores such as dropping children at school and extracurriculars, buying groceries, and transporting elderly relatives. For this reason, women are disproportionally penalized by bus fares. Of course, fares are not the only problem women face with public transport. To truly make it accessible ECAN would need to address concerns about safety and the fact that currently, bus routes don't cater to the more complicated transport patterns that women have (which means their trips take significantly longer), but removing fares, (even if only for women fitting those groups), is a positive start.

Any other comments on bus fares?

Removing fares is wonderful but many also avoid public transport because they find it confusing to understand how the busses work and because busses take so much longer than other means of transport (even than biking sometimes), so these issues also need to be adressed.
