It is great to see ECan looking into promoting our public transport option. Of the three options I support option 1 and feel this is a great example of a climate justice approach to the climate crisis - it will encourage selected residents to use buses as opposed to private vehicles which will reduce emissions as well as decreasing transport costs for those who need support. Ideally I would prefer a fourth option which would provide free public transport for all - please see details below.

It would be great to have a fourth option of free fares for all, to encourage all residents to use public transport in order to reduce our emissions further, as is needed to meet national targets. If we really want people to shift from public transportn there need to be several major changes. I also think we need to make improvements to working and pay conditions of bus drivers, increase services to reduce wait times for buses, and inparticular improvements of buses to the low income areas of our city (eastern suburbs), as well as an after midnight bus service such as those that other cities in Aotearoa provide.
