Further points I wish to add to the submission to Ecan's annual Plan 2022-2023

- 1. In the interests of people's health, reducing air pollution and greenhouse gas emissions, there must be a ban on the farming practice of burn-offs. We see huge fires with smoke spreading into the atmosphere regularly in Autumn across the Canterbury Plains. This is unacceptable when Ecan has done such a great job in the urban areas of improving winter air quality from wood burners.
- 2. No more resource consents for large scale fires to control wilding pines on farms. Country Calendar recently showcased a farm in North Canterbury burning off huge areas of wilding pines. I have been involved as a volunteer with both Ecan and Doc in controlling wilding pines and while there is not one easy solution, adding fire to the mix is an environmental nightmare. Much better to cut out when the wildings are small, or spray either from the ground or helicopter, and be prepared to continue to control for many years.
- 3. Funding to control weeds which are widespread and damaging to indigenous ecosystems. Wilding pines, lupins, broom, and due to climate change we will have many extra weeds to deal with in the future.
- 4. Funding for urgent and sustained control of Southern Black Backed Gulls which are a predator of our unique and endangered braided river birds. Ecan already has a management strategy. This needs to be implemented.
- 5. I support braided river revival and agencies working together to co-ordinate this. I know DOC have a focus on braided rivers, also LINZ and District Councils need to work with Ecan for better outcomes. As well as control of Southern Black Backed Gulls, work needs to be funded for predator control (stoat, possum, hedgehog, feral cats) and weed control on braided rivers.
- 6. More funding for control of browsing pests including deer, goats, pigs and wallabies in our forests to allow carbon sequestration to increase, and biodiversity.
- 7. Reduction of emphasis on widescale plantation planting of pines to ease our way out of climate change. We should be planting native trees that remain in the ground

forever to sequester carbon permanently and to provide habitat and indigenous biodiversity.

- 8. I support funding to increase the number of compliance officers so that consents are monitored and breaches are penalised.
- 9. Given that agriculture contributes to our emissions in a major way, there needs to be a levy on fertiliser that funds climate change initiatives.
