PLAN CHANGE 7 APPEALS COMMITTEE TERMS OF REFERENCE

Adopted by Council 13 April 2022

MEMBERSHIP:	Three members of Council
QUORUM:	Two (2)
MEETING FREQUENCY:	As required to fulfil the purpose and responsibilities of the committee
CHAIR:	One Chair

A. PURPOSE

1. To receive advice and provide guidance to the Chief Executive as to how the Council will respond to each of the appeals lodged on the Council's decision on Proposed Plan Change 7 (PC7) to the Canterbury Land and Water Regional Plan (LWRP).

B. SPECIFIC RESPONSIBILITIES

- The Committee will make all decisions necessary to fulfil the role and scope of the Committee, subject to the limitations imposed, for the duration of the High Court Appeals on PC7 to the LWRP, including:
 - a. Providing governance oversight in relation to PC7 to the LWRP (noting however that appeals are on points of law only);
 - b. Receiving and considering advice from legal counsel and technical staff regarding the appeals;
 - c. Providing guidance to the Chief Executive as to the Council's preferred approach and position in respect to each appeal.

C. DELEGATIONS

- 3. Subject to sections 4 to 6, the Council delegates to the Committee all the powers, functions and duties necessary to perform the Committee's responsibilities, except those that must not be delegated.
- 4. The Chief Executive has been delegated the authority to resolve High Court appeals on PC7 to the LWRP. The Committee will not be making decisions on the resolution of those appeals (with the delegation retained by the Chief Executive) but it will report to the Council on its work.
- 5. The Committee may make decisions on matters with a financial impact only where the related costs are budgeted for within a current, adopted Long Term Plan or Annual Plan, otherwise the matter must be referred to the Council for decision.
- 6. The Committee may not make a decision that is materially inconsistent with the Council's Long-Term Plan or Annual Plan.

Purpose

- To adopt the meeting schedule for Plan Change 7 (PC7) Appeals Committee until the end of September 2022 where new members may be elected or appointed following the 2022 triennial general election of members.
- 2. To discuss the Terms of Reference for this Committee.

Recommendations

That the Plan Change 7 Appeals Committee:

- 1. Approves the meeting schedule for Plan Change 7 Appeals Committee until the end of September 2022.
- 2. Notes the Committee's Terms of Reference.

Key points

- 3. Five appeals have been lodged on the Council's decision on PC7 to the LWRP. The appeals are matters before the High Court of New Zealand.
- 4. The CE has existing delegated authority to make decisions on behalf of the Council regarding the settling of a dispute or issues to be discussed at a Court directed mediation or any other dispute resolution in relation to any matter before the High Court, this includes the appeals lodged on PC7.
- 5. This Committee will provide a formal structure for Councillors to set policy direction and provide governance oversight in relation to PC7 (noting however that appeals are on points of law only). The Plan Change 7 Appeals Committee would receive advice from legal counsel and staff, and provide guidance to the CE in the form of recommendations, based on that advice.
- 6. The Council did not make a full delegation to the Plan Change 7 Appeals Committee. Rather, the Council retained the CE's delegation to resolve apppeals, which will ensure that the Council can comply with Court deadlines which are often required quickly and with limited notice. This is also consistent with how a number of other councils' appeals

committees operate. The Terms of Reference attached to this paper reflect this arrangement.

Background

- 7. This Committee was established and the Terms of Reference were adopted at the 13 April 2022 Council meeting. Local Government Act 2002 (LGA) specifically, Schedule 7 of the LGA provides that the Council may appoint a committee that it considers appropriate. A committee is subject in all things to the control of the Council and must carry out all general and special directions of the Council given in relation to the committee. The attached Terms of Reference set the direction for the Plan Change 7 Appeals Committee in this regard.
- 8. Any advice or information received by the Plan Change 7 Appeals Committee in respect of the appeals and the subsequent discussions regarding those appeals is confidential to the Committee, and in the case of legal advice will be subject to legal professional privilege. This information must not be shared or discussed beyond the Plan Change 7 Appeals Committee for any purpose. Managing the sensitive nature of the information to be received by the Committee will be easier with a smaller number of Committee members.

Cost, Compliance and communication

Financial implications

9. Financial costs associated with the resolution of appeals are generally funded from reserves. Legal expenses will be required to support the Plan Change 7 Appeals Committee and the CE, but those costs would be incurred in any event as part of resolving these appeals and will not be materially increased as a result of establishing the Plan Change 7 Appeals Committee

Risk assessment and legal compliance

10. The financial, legal, and reputational, risks associated are different for each appeal. The Plan Change 7 Appeals Committee will be advised of relevant risks as they relate to each appeal and will provide guidance and make recommendations on behalf of the Council to the CE as to the management of those risks.

Engagement, Significance and Māori Participation

- 11. Te Rūnanga o Ngāi Tahu and Te Rūnanga o Arowhenua have appealed the Council's decision on PC7. As an appellant, the involvement of Te Rūnanga o Ngāi Tahu and Te Rūnanga o Arowhenua will be facilitated through the normal judicial process.
- 12. Engagement and relationship building for the ki uta ki tai planning work programme will continue as scheduled, albeit separate to the appeals process.

Communication

- 13. Appeals on PC7 are High Court legal processes, any communications with other parties to the appeals will be managed by legal counsel and the Court. External communication regarding the appeals will not be made whist the appeals are before the High Court.
- 14. The notices of appeal are available on the Council's website, and this will be updated with information regarding the resolution of appeals as it is appropriate to do so.
