<b>Period:</b> <b>From: 0700 on Saturday 11<sup>th</sup> February 2023 to 1800 hours on Sunday 12<sup>th</sup> February 2023</b> <b>Unless revoked by the Harbourmaster.</b>	
<b>Reserved Area:</b> All that part of the Waimakariri River from 100m upstream of the Mount White Bridge in the Upper Waimakariri River to 100m downstream of the Waimakariri Gorge Bridge near Sheffield.	
<b>Map attached:</b> Yes	
<b>Purpose:</b> To reserve the area for use by race competitor kayaks and the race organiser's support and safety vessels including kayaks and jet boats associated with the event. All other jet boats other than commercial vessels usually operating in this location, all other vessels including power-driven vessels, non-race kayaks (including those of competitors no longer in the race) and rafts, tubes or other non-powered vessels shall be prohibited.	
<b>Reservation:</b> Except for commercial jet boats usually operating in this location or in the case of genuine emergency, no vessel of any kind shall enter into or navigate within the reserved area during the period of the Temporary Reservation without first having been granted the express permission of the Reserved Area Controller or an Environment Canterbury Harbourmaster. <b>This Temporary Reservation shall not have effect if the Waimakariri River Gorge leg of the race is cancelled.</b>	
<b>Conditions:</b>	
<b>Notice of Reservation to be:</b> <b>Displayed at:</b> As above. <b>Displayed by:</b> Richie Owen or delegate <b>Removed by:</b> Richie Owen or delegate Publication of notice of Reservation: Notice of this Temporary Reservation shall be made public by way of appropriate websites (in particular the Coast-to-Coast website) signage and media, Christchurch Star and Press and directly to representatives of known affected user groups, during the week preceding the event as a minimum. Notices of this Temporary Reservation shall be displayed where they may best be seen by river users at the following locations from Friday 12 <sup>th</sup> February 2021 , and removed the day following the event: At the Mt White Bridge kayak put-in; Alongside the access road into the Woodstock launching area; At the access route to the river at the Waimakariri Gorge Bridge; At the launching ramp on the Waimakariri River immediately upstream of the SH1 bridges; At any other locations routinely used for launching of powered or non-powered vessels.	
<b>A copy of the Temporary Reservation Certificate shall</b> be carried by marshals and other event staff who are able to advise other river users of the reservation.	
<b>Safety conditions:</b>  Those in support and safety vessels are to wear suitable PFDs at all times, and the vessels are to be appropriately equipped for their safety role. All competitors are required to wear PFDs as approved by the temporary exemption outlined as Part One of this reservation. The approved Coast to Coast safety plan is to be complied with and all competitors briefed as to the risks and hazards on the Waimakariri River The Holder of this Temporary Reservation Certificate shall undertake all reasonably practicable precautions to ensure the health and safety of all persons involved in the race.	
<b>Temporary Reservation shall not take effect if:</b> Conditions above are not met.
