#### 9.1 Waitaha Action to Impact Fund

Alison Bower, Community Partnerships Coordinator, and Environment Canterbury spoke to the Committee to provide the OTOP Water Zone Committee with an update on the Waitaha Action to Impact Fund as confirmed through Environment Canterbury's 2022-23 Annual Plan.

This financial year, planning to open the fund 18 July until 12 September.

How can we open communication to promote projects through the Committee. Applications are well vetted by the time it comes to the Committee including project management and (limited) ecological impact assessing. Beneficial for groups to hear about the funding through a variety of avenues; ECan social media, Water Zone Committees networking, mailing lists. (Regional) Council expanded the fund, would be good to see more projects across the region.

Project OTOP funded the Burkes Pass where the Waitaha Action to Impact Fund had declined.

It provides an update on the Waitarakao/Washdyke Working Group and Strategy. In conjunction with briefings to Environment Canterbury and Timaru District Council; both were well received. From the briefings a need for a steering group was identified.

Committee Members discussed the number of stakeholders involved, engagement process proposed, communications with key stakeholders, involving farming communities and industrial communities, exploring interventions to achieve outcomes desired.

Cyanobacteria blooms remain frequent in Lake Opuha, there is an understanding between Opua Water Ltd. and Environment Canterbutry on informing people using the water out of those rivers when a bloom occurs.
