lan has always taken his responsibilities very seriously and acted professionally – the embodiment of Pononga/Integrity. Ian is always thinking from the customer's perspective as well as carrying out his Environment Canterbury functions, and he is great at finding the balance between getting things done and ticking all the boxes.

Ian Heslop thanked the Council and senior staff for their support and vote of appreciation in recognising the benefits of exceptional river engineering, adding that each generation of river engineers added layer upon layer of benefit to the community. Ian also spoke on the characteristics of individual rivers and highlights of his career.

Living Wage Decision Statement

"I am pleased to announce that the Council has decided that Environment Canterbury will seek to become an accredited Living Wage employer.

Once accreditation is achieved from Living Wage Aotearoa, Environment Canterbury will be the first Regional Council to become an 'Accredited Employer'

Becoming a Living Wage fully 'Accredited Employer' means Environment Canterbury will pay all its employees at least the living wage. It also means that indirectly paid workers employed by contractors, delivering a service to the Council on a regular and on-going basis AND on our premises or on premises we control, are either on the current Living Wage or on milestones agreed as part of the contract.

Living Wage Aotearoa has outlined the benefits of being a Living Wage Employer. They say employers talk about having reduced staff turnover, a more productive work environment and increased business as a direct result of paying a Living Wage.

Workers talk about spending more time with their families, feeling valued, less stressed and consequently being happier and more motivated in their workplaces.

Staff will work with Living Wage Aotearoa, the PSA, and external contract providers on any steps necessary to achieve accreditation."
