#### 5.4 COUNCILLORS UPDATE - ENVIRONMENT CANTERBURY/WAIMATE/WAITAKI

Cr Sharyn Cain (Waimate District Council)

- Waihao Wainono Community Catchment Group AGM tonight (30.11.22) with speaker Jamie McFadden. Another planting day is scheduled on Saturday. On the agenda is also to discuss willow removal further up the catchment.
- Three Waters Reform continues. Waimate turned down first round of stimulus funding.
   Still a waiting game, along with Future for Local Government. Next meeting is out at Waihao Marae.
- Dan Mitchell updated the Zone Committee on the nitrate issue at Glenavy. Current levels sitting around 38 milligrams/litre. Expecting to circulate media statement as well as community meeting to discuss lifting of warnings and meeting of requirements of drinking water standards. Message to community is that Council will still supply potable water and discuss point of use treatment devices. Messaging will be clear and distinct, as users just want good safe drinking water. Need remains to upgrade treatment plant to meet other aspects including nitrates. De-nitrification measures will be implemented above 50 mg/litre and is in the longer-term vision.
- Draft Future for Local Government Review (FFLG) now open for consultation and feedback before formal draft is prepared to go to the ministry. It was agreed that this will be looked at more closely by the Zone Committee and discussed early in 2023. The report will be circulated.

Mr Jim Hopkins (Waitaki District Council)

- FFLG seems to be more of a Central Government takeover in many areas of Local Government.
- Waitaki moving forward in a range of projects on potable water treatment, and reticulated sewerage systems in readiness of the Three Waters Four Entities proceeding.
- Gearing up for a problematic Annual Plan, with signals from officers of higher-thananticipated rate rises. Half of Council is new and are still in process of induction training. It will be important to have a united Council with 2023 and expecting some hard decisions

# 5.5 LOWER WAITAKI CATCHMENT PROJECT UPDATE (NORTHERN FAN PROJECT) WITH MIKHAILA COLES AND PETER BURT

The Zone Committee were updated on planning for the Lower Waitaki Catchment Water Quality Project, focusing on reducing nitrate loss to waterways. Nitrate spikes generally when big water event occurs.

Currently working with ECan science team, as actions need to be specifically targeted to the catchment, ensuring effective outcomes within good timeframes. Once the scoping work is finished, there will be some planning undertaken in early 2023 working alongside MGI on critical source mapping.

It was highlighted the project needs full collaboration across the sector, and for all stakeholders to be aware of critical source areas.

The Committee will receive another update in the first quarter of 2023.

Andrew Oliver requested the Zone Committee's feedback on the Mainland Conservation Island Project Proposal. Mainland Islands are a new area of conservation management aiming to protect and restore habitats through intensive management of introduced pests in defined areas using ecological corridors being waterways (riparian buffers), fencing, geographical features or intensive management.

The Zone Committee offered feedback, including funding options and ways to begin the conversation and suggested a starting point would be to establish a steering group.
