5.3 COUNCILLORS UPDATE - ENVIRONMENT CANTERBURY/WAIMATE/WAITAKI

Waimate District Council Cr Sharyn Cain

 Waihao Wainono Community Catchment Group have had a meeting and recent successful planting day. Willow removal was discussed, with a further meeting planned at Waihao Forks for landowners further upstream. A mini audit will be carried out on what's there, what's been done and quick gains – mostly at the top of the catchment. The willow removal project is being led by the community, including a planned approach around the removal of slash. Another planting day coming up in April and an education day with schools. Area around Waihao Walkway beginning to look good.

LOWER WAITAKI SOUTH COASTAL CANTERBURY ZONE COMMITTEE MEETING MINUTES

- Three Waters Reform information is being demanded from Councils. There is big concern over instructions of 'waters' removal from the Long Term Plan including implications of this and awaiting further details. Outsourcing water services has massive implications and uncertainty such as civil defence implications.
- Nitrates at Glenavy is an ongoing beast, however readings continue to trend down, with no upward spikes which is very good news. Another public meeting in Glenavy in near future.
- Submissions to the Future for Local Government/Resource Management Act and Water Entities Bills continue to be made.

Waitaki District Council Cr Jim Hopkins

- 'Three Waters' hits keep coming. Water Services Legislation Bill submissions closed.
- Not just Council assets going, RMA reforms are complicated with a lot of new introductions and loss of local control.
- Wading knee deep into Annual Plan. wrestling with unpalatable rate increases and working hard to get down to acceptable level. There will be unavoidable cuts in service levels and servicing.
- Submission on the Future for Local Government that seems to have a focus more on wellbeing instead of assets and infrastructure.

5.4 HAKATARAMEA SUSTAINABILITY COLLECTIVE (HSC) AND WAITAKI VALLEY SCHOOL REPORTS

Juliet Gray updated the Committee on the Biodiversity Day at the Hakataramea River McHenry's picnic spot and also updated the Committee on Hakataramea Catchment work and details of their funding request. The Committee acknowledged the excellent work being made by the HSC.

Fraser McKenzie updated the Committee on the Know Your Catchment Project. Frustrations with the IT service provider, staffing shortages delaying completion of automatic updating feature. Concerns some sites may no longer be monitored by ECan and the lack of data from ORC. It is hugely important to have the underlying data, non-political that will drive decision making.

5.6 STRAWBERRY FARE REPORT

Very successful day with little cost.

The Committee agreed this was a good place to educate as it was different and targeted people that wouldn't be ordinarily attend more water-specific type gatherings and suggested it would be helpful to be alongside an appropriate Waimate District Council's site.

There could also be a possibility to involve/have information on other linked organisations such as Hakataramea Sustainability Collective, Waihao Wainono Catchment Group.

Notes of the Lower Waitaki South Coastal Canterbury Water Zone Committee Workshop 15 February 2023

1. Action Plan Objectives

5. Northern streams Catchment Group

Mike Burnett from Catchments Collective South Canterbury gave a presentation on the proposed 'Physiographics' project which will focus on the OTOP Zone. The committee agreed that it would be good for the project to extend into the Northern Streams area of the Lower Waitaki South Coastal Canterbury Zone, and that this could spark interest in forming a catchment group in the Northern Streams area.

Cr Cain noted that the Waihao Wainono Catchment Community Group have been looking at a Pod group. Suggested talking to Colin Hurst.

Action: Victoria Magazinovic to talk with Bruce Murphy, who previously had a contact list of interested farmers in the area, re initiating discussions again.
