The Chair provided the following information to the meeting regarding the recent Heathcote River/Ōpāwaho fish kill incident.

"A large number of dead fish were found in Heathcote River/Ōpāwaho on Thursday 2 March 2023 after a report coming in from a member of the community. When staff arrived at this site it was determined that the cause of the event was likely to be a discharge incident that resulted in an unknown contaminant entering the river or stormwater network. There was immediate concern that the unknown substance could be still in the water and so public advice and notification to agencies was given.

Our staff requested support from Christchurch City Council staff who helped to understand the extent and support investigation of the possible source of the incident. Water monitoring was undertaken, fish and water samples have been collected for analysis. A clean up to remove dead fish occurred yesterday and ongoing monitoring for harm to wildlife continues.

We want to acknowledge the actions of the community member reporting this event. We also want to assure the community that this is a priority situation and staff are continuing work to investigate the source and cause of this incident."
