#### A. PURPOSE

- 1. To oversee the development, implementation and review of Council's:
  - a. strategic direction and policies for transport and mode-shift;
  - b. set the operational direction to deliver public transport and mode-shift;
  - c. provide input into joint transport-related projects and initiatives;
  - d. development of integrated land use and regional transport; and
  - e. development of Council's position on regionally significant matters such as spatial planning.
  - f. To work in the spirit of genuine partnership and assist the Council in fulfilling its duties as a partner with Ngāi Tahu and in alignment with the principles contained within the Tuia Agreement. In particular, the committee will support effective partnerships with Papatipu Rūnanga, recognise the relevance of Te Ao Māori and affirm the importance of an enduring and collaborative relationship between Environment Canterbury and Ngāi Tahu Papatipu Rūnanga.

#### B. SPECIFIC RESPONSIBILITIES

- 2. Approve strategies, policies and guidelines to deliver clean air in Canterbury.
- 3. Approve transport strategies, policies, plans programmes and initiatives related to transport demand management and active mode promotion, including relevant aspects of the Regional Policy Statement;
- 4. Review and monitor performance trends related to public transport activities.

- 5. Advocate for the alignment of initiatives across the region with transport implications including spatial planning and land use planning including liaison with:
  - a. the Regional Transport Committee;
  - b. the Greater Christchurch Partnership Committee; and
  - c. territorial authorities in relation to the urban planning aspects of their District Plans.
- 6. Ensure that the Committee's decision making:
  - a. Considers climate-change related risks; and
  - b. Is consistent with Council's plans and initiatives to give effect to Council's declaration of a climate emergency on 16 May 2019.

#### C. DELEGATIONS

- 7. Subject to sections 8 and 9 below, Council delegates to the Committee all the powers, functions and duties necessary to perform the Committee's responsibilities, except those that must not be delegated.
- 8. The Committee may make decisions on matters with a financial impact only where the related costs are budgeted for within a current, adopted Long Term Plan or Annual Plan, otherwise the matter must be referred to the Council for decision.
- 9. The Committee may not make a decision that is materially inconsistent with the Council's Long-Term Plan or Annual Plan.

#### Purpose

1. To update the Committee on the progress of the Transport, Urban Development and Air Quality portfolio.

#### Recommendations

That the Transport, Urban Development and Air Quality Committee:

1. Receives the work programme report for updates to work programmes since the April 2023 committee meeting.

#### Background

- 2. On 17 June 2021, the Council adopted its Long-Term Plan 2021-31 (LTP) which established the Air Quality, Transport and Urban Development portfolio.
- 3. Through the Air Quality, Transport and Urban Development portfolio: We are prioritising sustainable and healthy living and working environments; connecting communities with a safe multi-modal transport network; and ensuring this enhances social, cultural, economic, and environmental wellbeing now and in the future. The programmes within this portfolio are:
  - Clean air
  - Transforming public transport
  - Integrating urban land use, and regional transport
- 4. The Air Quality, Transport and Urban Development portfolio has a total budget of \$114.38 million for the current (2022-23) year. This was established through the LTP and updated where necessary in the Annual Plan 2022-23.

#### Key updates to the work programme

5. Key updates to the work programme will be reported to the Committee as at the end of the nearest quarter to the Committee date. The timing of this Committee meeting means a quarter four update (to 30 June 2023) will be reported to the next Committee meeting on 9 August, 2023.

6. As this is not a quarterly update, the Air Quality, Transport and Urban Development portfolio Levels of Service and Key Initiatives are not reported in this paper.

#### Notable recent achievements/issues

#### Air Quality, Transport and Urban Development

- 7. On 18 May 2023, the Government announced Budget 2023, which proposes permanent, free public transport for under 13 year olds along with half-price fares for under 25 year olds, with funding available from 1 July 2023. These changes are an extension of the already announced Community Services Card and Total Mobility concessions. The announcement also confirmed funding to support an uplift to base wages for urban bus drivers to \$30 an hour, or \$28 for regional drivers (which are already in place in Canterbury) and to support improvements to driver conditions. At the time of this report writing, we are working with government and suppliers to understand the scope, financial and delivery implications of these announcements in relation to our fares package work and this will take some time. Given this, and using the Community Services Card initiative as an exemplar, we are unlikely to be able to implement these changes by the proposed 1 July timeframe.
- 8. Driver shortage response mitigation interventions continue to deliver improvements with missed trips for April averaging 1.6% per day. As at 23 May, we are currently tracking at 0.02% (7 missed trips) for the month. There is confidence now in planning a return to 10-minute frequency for the Orbiter route. This is currently being planned for July 2023 and will include an appropriate promotion campaign.
- 9. Safety enhancement investigation work has resulted in a new public transport code of conduct being published (https://www.metroinfo.co.nz/travel-and-fares-info/code-of-conduct/) and drivers receiving training on de-escalation and associated customer service. Additionally, in partnership with Christchurch City Council and others, an anti-abuse of staff campaign was developed and launched in early May. The Safety-Officer workstream has been paused pending Annual Plan budget reprioritisation considerations.
- 10. Staff are preparing briefings for Council in June to provide updates covering Public Transport Futures strategy and planning, Sustainable Public Transport Framework updates and service route enhancements.
- 11. Work has commenced on the planning of the frequency uplift on Route 7 approved through the PT Futures investment case and the Long-Term Plan. Current approvals will see a frequency uplift on Route 7 in fiscal year 2024/25. Council have expressed a desire to review the scope of this service change and this will form part of the upcoming considerations for the next LTP.
- 12. A high-level dashboard summarising key performance areas for Public Transport is attached.
- 13. The Greater Christchurch Partnership continue to develop the strategic framework and plan for Greater Christchurch 2050, in consultation with mana whenua and other partners.

- 14. Feedback on the Greater Christchurch Spatial Plan from community engagement was analysed and informed the development of the draft Spatial Plan during March and April. The Whakawhanake Kāinga Komiti approved the draft Spatial Plan for the purposes of public consultation at its May 2023 meeting. Partner governance, including the Canterbury Regional Council, subsequently endorsed the draft Spatial Plan on 16 and 17 May. Cabinet endorsement of the draft Spatial Plan will be sought mid-2023, with public consultation scheduled between mid-June and end of July, during which feedback will be sought by submissions.
- 15. Progress is being made on the speed management objectives of the Regional Speed Management Plan. The Canterbury Regional Transport Committee (CRTC) considered approving the objectives and planned July – September engagement with community and Rūnanga at its 1 June 2023 meeting. The speed management objectives will likely go for public consultation in February 2024 with the Regional Land Transport Plan.
- 16. The monitoring framework, significance criteria and significance policy for the Regional Land Transport Plan have been reviewed and updates provided to the Transport Officers Group. These went before the CRTC in June. In the meantime, the review work is focused on ranking regionally significant activities and developing August/September public engagement approach, including effectiveness for Māori. Scoping for innovative financial opportunities, and updating the narrative in the document to reflect the new strategic direction, are also being progressed.
- 17. Partly due to increases in both the commercial area of, and commercial transport in Washdyke, consistent increases in particulate matter exceedances have been recorded, prompting coordination of mitigation efforts across consent holders, territorial authorities, the New Zealand Police Commercial Vehicle Investigation Unit (CVIU) and zone delivery.

#### Cost, compliance and communication

#### **Financial implications**

18. No decisions concerning funding are sought through this report, and financial portfolio and programme reporting is provided to the Audit, Finance and Risk Committee.

#### **Risk assessment and legal compliance**

19. No legal compliance issues have been identified for this progress report.

20. Engagement with Papatipu Rūnanga, mana whenua and the community are an important aspect of much of the work that occurs in these programmes and is embedded within the programmes.



#### Purpose

- 1. The purpose of this report is to seek delegated authority to the Chair of the Transport Urban Development Air Quality Committee (TUDAQC) to finalise and approve a Canterbury Regional Council submission on the draft 2024 Government Policy Statement on land transport (GPS).
- 2. The draft 2024 GPS is expected to be released for public engagement in June 2023. Staff are anticipating a very short four-week timeframe for providing feedback that may not provide for a draft submission to be considered at a usual meeting of this committee or council. Staff are therefore seeking to circulate a draft submission to members for feedback and input via email, and final approval by the Chair.

#### **Recommendations**

That the Transport, Urban Development and Air Quality Committee:

- 1. Delegates authority to the Chair of the Transport, Urban Development and Air Quality Committee to approve a submission on the draft 2024 Government Policy Statement on land transport, prior to the submission closing date.
- 2. Agrees that (at a minimum) any draft submission will be circulated via email to all Committee members for feedback and input, with a minimum of three working days to provide feedback.
- 3. Notes that the Chair will retain final discretion over any sought changes to the draft submission.

#### Background

3. In June 2023, Te Manatū Waka/the Ministry of Transport is expected to be engaging on the Draft 2024 Government Policy Statement (GPS) on land transport. The draft GPS was expected to be released on 8 June 2023 however this has been delayed. An exact release date is currently not known.

#### What the GPS does

- 4. The GPS sets the Government's priorities for land transport investment over a ten-year period. It also directs how money from the National Land Transport Fund (NLTF) is spent on transport activities, such as public transport, state highway improvements, local roads, and road safety (referred to as activity classes).<sup>1</sup>
- 5. Waka Kotahi NZ Transport Agency and local authorities need to ensure spending on transport reflects Government priorities outlined by the GPS. The GPS guides Waka Kotahi and local authorities in their investment in land transport by signalling:
  - what the Government wants the land transport system to achieve, by setting strategic priorities, and identifying ways to achieve them
  - how much revenue will be raised for the NLTF from petrol excise duty, road user charges, and motor vehicle registration and licensing
  - how the Government wants the funding to be allocated across different types of land transport system activities, for example, roads, public transport, active transport or road safety.
- 6. The GPS will set desired funding ranges for each activity class within which Waka Kotahi and partners will prioritise activities for funding.
- 7. The GPS is reviewed every three years and is a core requirement of the Land Transport Management Act 2003. The first GPS came into effect in 2009 and the most recent 2021 GPS was published in September 2020.

#### What the GPS does not do

- 8. The GPS cannot direct or guarantee funding for specified transport projects, like an individual road being upgraded or a specific public transport route becoming more frequent. This means the GPS does not say how much will be spent in a region or whether specific projects will get funding.
- 9. Waka Kotahi prioritises projects for funding within the GPS activity classes when it develops the National Land Transport Programme (NLTP). The NTLP responds to the GPS and Regional Land Transport Plan (RLTP) priorities.

#### Discussion

#### Proposed process for elected member engagement

 Environment Canterbury staff are already committed to developing a joint Canterbury Regional Transport Committee and Canterbury Mayoral Forum submission on the draft 2024 GPS. Staff were advised that the Canterbury Regional Council may also want to submit on the GPS. The topic falls within the terms of reference of this committee.

- 11. If possible, the staff preferred option is to bring the item to a full meeting of committee or Council. However, because the very constrained four-week engagement period, there may not be an opportunity to do so.
- 12. Staff are therefore seeking a delegation to the Chair, to allow a draft submission to be developed and circulated via email to members for feedback and input, prior to the submission closing date.
- 13. We expect four-week timeframe would provide staff with approximately one week to draft a submission, and a minimum of three working days for Councillor input. Staff will endeavour to have a draft to Councillors earlier if possible.
- 14. It is important to note that because of the short timeframe, and the two Canterbury Regional Transport Committee (CRTC)/Canterbury Mayoral Forum (CMF) and CRC submissions being progressed concurrently, staff anticipate the draft Canterbury Regional Council submission to substantively align with the joint CRTC/CMF submission but capture additional points of feedback pertinent to this Council's responsibilities.

#### **Proposed content**

- 15. Canterbury Regional Council staff have had an early indication (as at 30 May 2023) from Te Manatū Waka staff on the likely direction of the GPS priorities at a high-level. Staff are anticipating good alignment of the draft 2024 GPS with the existing strategic priorities outlined in the 2021-31 Canterbury RLTP and greater recognition of, and funding for, public transport activities. A Canterbury Regional Council submission is therefore likely to be supportive of the GPS overall.
- 16. Further information on the content of the draft GPS will be provided in a later briefing to members.

#### Cost, compliance and communication

#### **Financial implications**

17. The staff time involved in drafting a submission is provided for in existing budgets.

#### **Risk assessment and legal compliance**

18. There are no substantive risks associated with this decision.

#### Engagement, Significance and Māori Participation

19. Staff have sought the input of the Chair and senior leaders on the process outlined above. There has been no engagement with Rūnanga or other parties on a Canterbury Regional Council submission to date.

#### **Climate Change Impacts**

20. This decision has no direct climate impacts. However, effective advocacy and input on the 2024 GPS has the potential to improve the collective government agency response to a changing climate.

#### Communication

21. There are no planned public communication activities associated with this decision. If this committee decides to proceed with a submission, the final version will be brought to the next usual meeting as an information item. It will also be made available on the Environment Canterbury website.

#### **Next steps**

- 22. If a submission is sought, then staff will proceed to draft a submission in the week following the release of the draft GPS. A draft submission will be circulated to Councillors with a window of three working days (at a minimum) to provide feedback.
- 23. Staff will consider how to fold in any feedback received before it is considered and signed off by the Chair prior to the close of the engagement period.
- 24. Once submitted, Te Manatū Waka, the Ministry of Transport, will prepare a public summary of submissions and use the feedback to make changes to the GPS.
- 25. The final 2024 GPS is expected to be published around September 2023.
