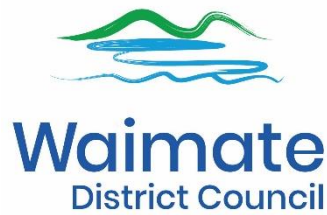

5.1 CORRESPONDENCE REPORT

5.1 DECLARATION OF INTERESTS REGISTER

Suzanne Eddington owner of land at Waihao.

Frazer McKenzie is no longer the Independent Chairman of Waitaki Irrigators Collective.

5.2 TE REO WORDS As presented.

Michael noted the reo is pretty basic – **manu, rakau, ngahere**.

Jen Fellowes asked Michael to run through the pronunciation and Jonnie Rutherford asked for clarification of singular v plural.

5.3 WAI CONNECTION UPDATE

Jessica Halsey presented the wai connection and her role as regional coordinator and engagement services officer based in Christchurch. Funded by MfE in turn funded by jobs for nature – current funding runs to June 2025.

Aim: tailored support to catchment group issues: knowledge, tools and expert support.

National v regional support. National backed by mountains to sea conservation trust and EOS. EOS technical and science support.

Cr Hopkins asked what the letters EOS stand for – Erin and Shelley (founders of the company)!

12 regions nationally have partner organizations with associated support people. North, mid & south coordinators – 15 catchment groups supported in Canterbury.

Jessica summarized the EOS engagement programme i.e. science + engagement. This was followed by the catchment selective pathway i.e. regional hui; regional needs assessment; signed off by MfE.

The wai-connection will offer:

- A summary of resources, govt docs et al available online along with map-based summary of each catchment.
- Science expertise
- Real support from real people (regional manager / community connections / catchment coordinators / FWP's/ support finding funding / NZLT support).

Cr Hopkins asked if Waitaki District Council is included in regional hui? Jessica noted that EOS are in planning phase in this space. Cr Hopkins will pass on the appropriate contact.

Bruce Murphy asked what reception was received from irrigation schemes? Jessica: catchment groups are specific to awa – schemes being larger than an awa. This project specifically aimed at the rural community.

Action: Facilitator to send Jessica the link to 'Know your Catchment'

Bruce Murphy noted duplication of aims and resources and queried if OTOP had a similar view. Cr Cain noted they did when presented with the same EOS presentation. Suzanne noted EOS is a private business, Jess noted that part of their brief is to facilitate funding for catchment groups.

Cr Cain felt that there is a justifiable purpose for EOS to be in the space to support local catchment groups, whilst at the same time noting the frustration of duplication.

Jakki Guilford noted that the committee has struggled to find coordination support for catchment groups – hence noting that EOS can be a benefit.

Action: Dave to email out EOS slides.

Jakki Guilford asked if there is scope for new groups to be in the scheme – Jessica noted that groups who are 'in formation' will be.

Cr Cain noted that CWMS committees are the go-to resource to approach in this space.

Jen Fellowes wanted clarification around where EOS sits in support of catchment groups. Jess noted it was not about duplication.

Michael McMillan asked if funds are available for other groups aside for catchment Groups – Jessica said yes with the exception of urban groups.

5.4 OUR LAND AND WATER CATCHMENT SYNTHESIS PROJECT

Lee Matheson, Managing Director, Perrin Ag

Our land and water science challenge has commissioned Perrin Ag to focus on how we transform and deliver (farm outcomes?).

Focused on how we potentially transform and adapt our farming systems to deliver the water quality outcomes.

How landscapes change with use to achieve water targets. Looking at a variety of indicators to achieve efficient sustainable use of water that gives good economic and environmental outcomes. Mitigation to factor in farmer, community aims with key boundaries e.g looking at outcomes with no trees. Lee's work aims to validate water quality outcomes with the constraints that the community desires – and will the model agree with it. Lee noting in Rotorua he's working with implementing 20% decreases in N, meaning farms will look different over time.

30 – 50 farmers needed across the Plan Change 3 sub catchments for telephone interviews of 20 – 25 minutes. Farmers paid for their time – with online survey, also paid. Mid – Oct 5-6 farmers required for case studies – all anonymous. For case study farmers, they will receive in depth reports. Lee noting the importance of future focus through farmer engagement. Individual responses will remain private, however over all learnings & insights will be made public. 15 September is when model inputs need to be identified. Michael suggested that Lee's information be given out to potential participants rather than committee giving contact info to Lee.

Jen: asked clarification on the model: Lee – once the model is set up it will exist to be reused for catchments and to input different outcomes, scenarios, outcomes.

Bruce: Noted we're the third least productive in the OECD and asked about productivity gains: Lee – could consider productivity gain as a mitigation, looks at an intergenerational outcome.

Pete: Clarified that this is work that regional councils would appreciate. What's the incentive to change? Lee – knowing is better than not knowing- and being able to contribute to owning the outcomes.

Cr East: Has concerns around the word 'modeling' ... wants to see honesty about being upfront about assumptions, applicability of data and margins of error as it may apply to our district that gives a credible result. Lee: results will be validated with farmers.

Cr Jim: Can Lee challenge the national bottom lines based on (the report tabled) – eluding that the NPS is leading us to a lower standard of living. Lee: if the model suggests that the model results in outcomes that are untenable – this then is a finding of the research, which could be used by other organisations, such as the regional council to run further modelling.

Bruce: What is the target audience? Lee: Govt - National Science Challenge – so Minister of Science.

Cr Cain: Can questions be sent out in advance? This as a means of mitigating the sense of ill-will 'out there'. Lee to send via the Facilitator to distribute to committee.

Need inputs to the model by Sept 15 – He requests that organisations contact their members to see if they are willing to be part of the survey and if so to contact Perrin Ag/Lee.

The committee would welcome Lee to report back at a later date.

5.5 ENVIRONMENT CANTERBURY ZONE DELIVERY UPDATE

Peter Burt Zone Lead Environment Canterbury

Peter gave an overview as per report – essentially BAU.

Compliance based on consent conditions

A compliance officer dual role with Waimate District Council Dual and ECan works well. This person is first cab off the rank for any pollution events in the zone.

Peter outlined the key compliance issues, high priority consents.

There is one Land Management Advisor in the zone– hence focus and prioritization is essential.

Land management advice activities such as the focus on the Northern Fan / Waihao drinking water, intensive winter grazing, weed control in the Hakataramea Valley, and support for catchment groups.

Bruce: FWFP – how does this sit with RPS? Pete: education and engagement over the planning phase.

Bruce noted no tangible guidance from ECAN with regards FMU's – esp given the size and impact of MGI in this zone. Jakki noted the committee as community reps should take leadership in this space – engaging with the community asking how can the committee support them in this space.

Annual Plan now approved, starting on the Long-Term Plan process.

Local Government AGM held in Christchurch recently.

Wallaby Control & Wilding Pines – drone technology being used to address this issue.

Coastal issues south of Banks Peninsula – options being discussed around coastal erosion and managed retreat. Discussions around critical infrastructure – what is and what isn't.

Cr Cain – Waimate District Council

Signage boards now in place on the Waihao walkway.

Birds on the Wainono Lagoon discussed – black swans & geese a tentative issue.

Denitrification Plant discussed – expensive to run, better to deal with the cause and run only the plant only when necessary.

Reform ongoing – RMA / 3-waters etc.

Cr Hopkins – Waitaki District Council

Cr Hopkins noted rising sea levels in the Waitaki. LTP issues around excluding 3 waters.

Working on the Long-Term Plan.

Bruce Murphy: Concerns over comms staff being employed over the likes of LMA's – committee wanting more staff on the ground for education & engagement. Councillor East to pass this

concern on internally.

Lower Waitaki South Coastal Canterbury Water Zone Committee

Declaration of Interests Register – Amended 17 February 2023

Keeping a Zone Committee Members' declarations of interest register allows Zone Committees to identify and manage a conflict of interest when it arises. The Office of the Auditor General notes a conflict of interest can arise when: "A members or officials duties or responsibilities to a public entity could be affected by some other interest or duty that the member or official may have."¹ If a member is in any doubt as to whether or not they have a conflict of interest, then the Member should seek guidance from Catherine Schache (General Counsel, Environment Canterbury), the Zone Facilitator and/or refer to the following guidance: <https://www.oag.govt.nz/2010/lamia>

Types of Interest to be documented in the register:

- Employment, trade or profession carried on by the Member or the Member's spouse for profit or gain
- Company, trust, partnership etc for which the Member or their spouse is a director, partner or trustee, or a shareholder of more than 10% shares
- Address of any land in which the Member has a beneficial interest and which is in the area of the Zone Committee
- The address of any land where the landlord is Environment Canterbury, Waimate District Council or Waitaki District Council and the Member or their spouse is a tenant; or
the land is tenanted by a firm in which the Member or spouse is a partner, a company of which the Member or spouse is a director, or a Trust of which the Member or spouse is a Trustee.
- Any other matters which the public might reasonably regard as likely to influence the Member's actions during the course of their duties as a Member.
- Any contracts held between the Member or the Member's spouse and Environment Canterbury, Waimate District Council or Waitaki District Council, including contracts in which the Member or their spouse is a partner, a company of which the spouse is a director and/or holds more than 10% in shares, or a Trust of which the Member or their spouse is a trustee (noting that no committee member should be a party to a contract with Environment Canterbury or Waimate or Waitaki District Council if that value is more than \$25,000 per annum)
