# 6 Updates from Banks Peninsula Zone Committee Members

Members highlighted events/meetings/issues relevant to the Zone Committee.

- The Stormwater Superhero Trailer has been taken to two events (Lyttelton Market 7
   October and Governors Bay Fete 15 October), alongside the joint ECan-CCC-Te Whatu Ora
   water quality for contact recreation display, and more are planned at Orton Bradley Park
   on 22 October and Lyttelton Market on 4 November. An event is also being organised for
   Akaroa Harbour.
- Work is underway on the joint project by Banks Peninsula and Christchurch West Melton Zone Committees and Whaka-Ora Healthy Harbour for Erosion and Sediment Control documenting and sharing practical knowledge and best practice application, along with several other initiatives identified for follow up implementation at the joint 27 April 2023 erosion and sediment control workshop.

- Participation in the Coastal Hazards Adaptation Panel this process is currently at the stage of getting community feedback on whether the options for "pathways" for adaptation are on the right track.
- Wairewa catchment planting days, catchment group development, planning for the Lake Wairewa opening, fish passage, work on taonga species with Environment Canterbury, state of Kaitorete Spit annual survey.
- Discussion with Banks Peninsula Conservation Trust regarding establishing a convenant over further area of bush on own property.
- Tribal Climate Change symposium at Lincoln University managed retreat. A lot of marae are located very close to waterways.
- Climate Change Adaptation Plan for Akaroa and surrounding areas.
- Te Rūnanga o Ōnuku application to a fund that mana whenua are able apply to.
- Upcoming Tuia programme meeting concerns regarding changes required to Regional Policy Statement.
