# Target 2: 41% reduction in greenhouse gas emissions from land transport in Canterbury by 2035

While Council agrees that greenhouse gas emissions need to reduce, this needs to be carefully balanced to ensure that it is not at the detriment of our communities. Waimakariri is a diverse district with rural activities and lifestyle block, as well as urban areas. In rural and lifestyle areas, choices for alternate modes of travel and public transport are limited or non-existent. While electrification of the fleet will help, careful consideration will need to be given to peri-urban and rural areas. Urban areas already have to do the heavy lifting in terms of emissions reductions.
