6. Te Reo Maori

Facilitator -Dave Moore

To increase the te reo knowledge of the Zone Committee, new words or expressions are introduced at each meeting.

Ki uta ki tai – was the meeting's expression.

Ki uta ki tai encapsulates the need to recognise and manage the interconnectedness of the whole environment. This term reflects the Manawhenau view of environmental and resource management. It is a traditional concept representing the holistic nature of kaitiakitaka, which must be exercised throughout all environments as they are all connected from the mountains and great lakes, down the rivers to the estuaries, and then to the sea.

7. General Business

7.1 Councillors Update – Environment Canterbury/Waimate/Waitaki Cr Hopkins – Waitaki District Council

- Like all local councils, Waitaki is wrestling with the issue of high rate rises.
- Three Waters still sits with the council and that brings approximately \$60 million worth of upgrades that haven't been budgeted for.
- The Long Term Plan has been deferred as the council comes to terms with the changes they face. Council will run with an Annual Plan for the 2024-25 period.
- Stressful times too as Taumata Arowai impose strict and unworkable time frames.

Sharon Cain - Deputy Mayor Waimate District Council

- Times of uncertainty for councils as Three Waters remain with council.
- It is very dry in Waimate but there have been no imposed restrictions apart from Hook which is on a conservation notice.

 Cr Cain is shocked that some people are more concerned about the ability to water their garden rather than making sure that there is enough clean water for drinking.

Cr David East (Environment Canterbury)

- Ecan is facing abuse as ratepayers hear of draft rate rises of 24.2%
- Ecan is reviewing the future of zone committees.
- There may be a move to focus on a catchment approach eg splitting Waitaki in half.
- RMA Ecan has a huge back log of resource consents.

The members of the committee who visited the Hakataramea Sustainability Collective at the local river for Biodiversity Day were impressed by how much work a small community of volunteers had achieved. Cr Hopkins said it was an outstanding achievement and Cr East said he had given the collective a glowing report and continues to support their work.

Cr Cain suggested other options for funding – Mid and South Canterbury Trust Grants and Fonterra Environmental Projects.

Dave Moore will send information to Juliet on the two funding options mentioned above.

7.6 Climate Change Update

Andrew Oliver (WDC) provided a presentation on Climate Resilience - an outline of the Waimate District Council's Climate Resilience Strategy pathway – why and how we're doing it.

He is hosting action plan workshops in Waimate for the month of April. Information documents were presented to the committee.

7.7 Kurow Wetlands Group

Report received from Karen Turner, Kurow Wetland spokesperson, detailing where the funding they received from the committee has been spent. She was thrilled that the committee was able to walk us around the wetlands area and view the project.

The committee reiterated that the Kurow Wetlands Group had been successful with an incredible project that the community, tourists, and cyclists on the Alps to Ocean track can enjoy – all done by a team of volunteers who wanted to enhance water quality and wetlands.

Karen has asked if the LWSC CZ committee would like signage on the track to acknowledge the support of the committee.

Sam Moreton (Ecan) will look in the logistics of this and will report back with a proposal.

7.8 LWSCC ZC Field Trip Report 16 February 2024

It was a wonderful day and attendees were impressed with all the work that is being achieved by these groups.

7.9 Zone Committee Updates

A key point is that Ecan is conducting a review of CWMS zone committees which will focus on what structure, function and resourcing are needed to support local freshwater leadership in the future.

Engagement with Zone Committees is planned for late March – early April. This was discussed and it was decided to hold our regular meeting on April 10, 2024, starting at 1pm with a workshop and then follow with the monthly meeting, if required the option for online attendance.

8.0 John Benn (DOC) Online

John wanted to make the committee aware of the Canterbury Biodiversity Fish Habitat Fund which closes on 19/4/2024. This for endangered and threaten species. For more information please refer to ECANZ website.

8.1 Peter Burt - ECANZ zone lead

ECANZ provided an overview of compliance in the Lower Waitaki South Canterbury Area. General concerns include crop double burns and odours.

They are recruiting for a compliance management officer.

There is concern about St Andrew's landfill which is eroding into the sea. It could cost \$135,000 for complete removal.

Cr Jim Hopkins said that a similar thing was happening in Waitaki with the unauthorized Beach Road landfill and also the Hampden site.

High nitrate in Lower Waihao drinking water scheme is an ongoing is a significant issue.

Report

In relation to the minutes for the Lower Waitaki South Coastal Canterbury Zone Committee Workshop held at the Waihao Marae on 13 September 2023, under the heading "Water Quality data", in the last paragraph (page 14) that is attributed to Kennedy Lange and Trudy Heath, the recorded minutes are incorrect in reference to the fact that the Gail Tipa produced an "Iwi Management Plan" that was incomplete. It is recognised that Gail Tipa was contracted to produce a Mahinga Kai Iwi Management Plan for the Te Rūnanga o Waihao and did in fact comprehensively complete the work. The Te Runanga o Waihao executive are in receipt of that Plan and it is awaiting their action.

Proposed amendment to the minutes

Kennedy: a document was created back at the time of Te Mana O Te Wai funded project by MFE, the Rūnaka engaged Gail Tippa to produce an "iwi management plan" document. but wasn't completed. Trudy confirmed it is still available but is incomplete. It would be good to re look at this.

Planting out the Waimate Gorge waterway with native plantings to assist in both bank stability and enhancing biodiversity habitat.

Purchasing native flax (Phormium tenax), Toetoe (Austroderia richardii), Cabbage trees (Cordyline australis), Coprosma rigida, ribbonwood (Plagianthus regius), Carex secta, \$10 X 200 = \$2000

Describe the outcomes or impacts of this project:

Outcomes or impacts are what will change or who will benefit from this work, including enduring benefits. For example, fencing off springheads will improve biodiversity and improve stream health.

Suppression of Phalaris arundinacea weed species and other exotic grasses that clog waterways and hinder aquatic biodiversity. Enhanced bankside native habitat.

List the key outputs of the project:

An output describes what your group is proposing to do and is measurable. For example, install 250 m of fencing, or train 25 volunteers. Outputs are important and may be used as milestones in a funding agreement.

Plant 200 native riparian plants in the lower to mid-Waimate Gorge. We have 2.2km of

stream running through the gorge, so we are doing the planting in stages.

Identifying and championing new and existing riparian, stream and wetland projects providing the most benefit for water quality in the zone.

Tell us what activities you're intending to do and when you intend to have the project completed (timeline):

This is a project that can be completed quite easily as the terrain is flattish. It will involve bringing our local community and schools together to plant. Site preparation and post planting care would be minimal. The project could be finished within 3 months depending on soil moisture content.

Tell us why you think your project is feasible/realistic:

We have community buy-in and support based on our track record to date. The terrain is easily accessible for planting as some vehicles can drive and deliver to the site. Ample evidence supports native species as a means of enhancing biodiversity and stream bank stability. We have already planted along the stream bank for about 200m.

Tell us about the project management, including leadership and financial oversight:

We have a robust and well established committee who are already proactive in the planting, management and financial space. We have planted 1600 plants so far in the reserve, most of this was done by the committee and friends and family and also a weekly plant working team (depending on weather). We do grow some of our own plants from seed, but mainly buy in plants from the local nurseries.
